January 27, 2021

The Board of Trustees of Defiance Public Library met to re-organize on Wednesday, January 27, 2021, via Zoom virtual meeting; notice of said meeting pursuant to O.R.C. 121 having been posted.

President Chris Korhn called the meeting to order at 4:00 PM. In attendance were Board members: Susan Mack, Jayne Yoder, Laura Connor, Beth Michel, Kenyotta Stantz and Ken Boroff. Fiscal Officer Appointments and Bonds
