- The Fiscal Officer of this Board is hereby authorized and directed to deliver a certified copy of this resolution to the Defiance County Auditor.
- It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revise Code.
